FEE SCHEDULE

TAX RETURNS:

QUARTERLY FUEL & MILEAGE TAX RETURNS:

1 Units*	\$120 per quarter (billed at \$40 per month)
2 or more Units*	\$25 per vehicle per month

- ✓ \$5.00 per month *discount* is given for each month trip logs are turned in by the 5th of the month following travel.
- ✓ \$30 per truck **additional fee** charged when all trip records are submitted at the end of the quarter.
- ✓ To meet filing deadlines, all trip records and fees for services must be in our office 15 days prior to reporting deadlines.

* The number of vehicles for which you are charged is equal to the number of decals you have been issued. If replacement decals are ordered, you must cancel previous decals so that licensed vehicles are properly accounted for and charges are correct.

AUTHORITY & MISCELLANEOUS PERMITS:

◆ California Authority (CA#, MCP, BIT)*	\$250.00
◆ Federal Authority (DOT, MC, BOC-3)*	\$350.00
◆ Misc. Applications & Renewals (UCR, EPN, BOE-106 etc.)	Varies

ADDITIONAL SERVICES:

(Fees vary due to the number of vehicles being reported)

◆ Miscellaneous Reports	-	\$35.00 +
◆ Miscellaneous Property Tax Returns	-	\$75.00 - \$150.00
◆ Amendments to Quarterly Reports	-	\$50.00
◆ Mileage/Route Calculations		\$50 per truck per quarter/\$15 per route
◆ Credit Card Processing Fees		3.5% of charges
◆ Audits & Consulting		\$85 per hour (1 hour minimum)

+ Basic fees stated per report are for fleets of 1-2 trucks. Additional fees *may* be added for e-filing charges, bookkeeping (if needed), larger fleets, longer reports and/or additional Schedules and Forms attached to basic reports. Please call for quote.

** IFTA decals are \$2.00 per truck; New Mexico e-permits are \$5.50 per truck; Oregon permits are \$8.00 per truck; New York permits are \$15.00 per truck if by mail - \$36 if expedited through Custom Permit Service.
