KANSAS ANNUAL CARRIER REPORTS

If you are registered to operate in all 48 states, you will be receiving an annual tax report from Kansas. DO NOT IGNORE IT! Even if you did not go to Kansas during 2009, this report must be filed! Failure to file will result in additional penalties, fines and assessments. If taxes are due, expect your 1st bill in December. The 1st half of the taxes will be due December 20, 2010 and the 2nd half of the tax payment will be due May 2011. You will be notified when it is time to register and given adequate time to complete the process before enforcement begins. Right now, enforcement is limited to 2008-2009 UCR enrollments
