**Apr 11<sup>th</sup>** – Kansas Annual Carrier Reports due!

**Government Stimulus Payments . . .** will start being sent to all **filers** of their 2007 Tax Returns in May. To qualify for a one time payment of as much as **\$600** for individuals or **\$1,200** for joint filers plus **\$300** for each qualifying child under 17, file your 2007 tax return by 4/15/08. Even if you would not normally have to file a tax return, you need to file one this year in order to receive your checks from the IRS. *Call us if you have any questions!*

## Unified Carrier Registration Agreement (UCRA)!

Be on the look-out for the 2008 Enrollment forms for the UCRA! There will be no increase in fees this year, but the renewal will be underway sooner this year - sometime this spring.

The UCRA program is replacing the old Single State Registration program and the fees you pay are to help offset the cost of your base state's motor carrier safety programs and enforcement.

It is our understanding that California has their program ready to go which means you will not have to select a different base state for payment of your UCRA Fees. Please give our office a call when you receive your 2008 enrollment forms so that we can assist and/or guide you.

## E-Filing of 2290's Coming Soon!
