## Important Dates

**Dec 31<sup>st</sup>** – This year the Board of Equalization mailed IFTA decals directly to you. All of our clients whose accounts were current have already received their decals. Please send us a copy of your IFTA license so we have it in our files. **If you did not receive your decals, please call our office. It means there is a problem we need to help you resolve before the grace period expires.**

**Jan 5<sup>th</sup>** – December Trip Logs received by today earn a \$5 discount on next months billing!

**Jan 10<sup>th</sup>** – All trip logs for Oct, Nov & Dec are due so that your 4<sup>th</sup> Quarter IFTA reports can be filed by the filing deadline.

**Jan – March** – Watch for miscellaneous tax forms from Arkansas and Kansas to arrive in your mail. DO NOT IGNORE THEM! If you would like our assistance just send the form to our office and we will help you! Penalties and interest are assessed if you do not respond.
