## Important Dates



**Jan 1<sup>st</sup>** – There are no grace periods for UCRA, New Mexico or Oregon renewals. All fees are due on 12/31/2010. If you need help completing your UCRA New Mexico or Oregon renewals, please e-mail us at [triplogs@earthlink.net](mailto:triplogs@earthlink.net).

**Jan 5<sup>th</sup>** – December Trip Logs received by today earn a \$5 discount on next months billing!

**Jan 10<sup>th</sup>** – All trip logs for Oct, Nov & Dec are due so that your 4<sup>th</sup> Quarter IFTA reports can be filed on time. If you haven't already sent them in, please do so today!

**Jan 15<sup>th</sup>** – Please contact our office if you have not received your IFTA decals! If your 3<sup>rd</sup> Quarter IFTA tax return was not filed on time, you will not get 2011 decals until the 4<sup>th</sup> Quarter tax return has been completed.. File your 4<sup>th</sup> Quarter early so your decals can be released before the grace period end.

**Feb 28<sup>th</sup>** – The IFTA Grace Period ends.

**Jan – March** – Watch for Arkansas and/or Kansas tax returns to arrive in your mail. DO NOT IGNORE THEM! If you would like our assistance just send the form to our office and we will help you! Penalties and interest are assessed if you do not respond.

**IFTA DECALS** have been mailed from Sacramento. Please send us a copy of your new IFTA license so we have one in our files. If you have not received them by 1/15/2011, please contact our office so we can follow-up on your behalf.
