Unified Carrier Registration (UCR)!

After much delay . . .
UCR registration for 2010 is now due!

The fee structure is final – and different from last year. In a nutshell - fees have been raised but trailers are no longer a part of the vehicle count. Enclosed is more information about UCR, an order form, and an invoice.
