UCRA REGISTRATION!

Enforcement begins 6/8/2008!

2008 🎵... must be completed by May 15, 2008! If you have not already returned the Registration Request Form to us with your check for fees, please do so today!!

This registration is done on-line and there will be no paper permit issued. Instead, your DOT profile is updated to reflect your current registration. If you are stopped on the road or at the ports, the enforcement officials will be able to look on their computers to verify that you have registered for 2008.

Please be aware that if you did not enroll for 2007, you must **pay fees now for both 2007 & 2008!** Please call our office if you have any questions.

E-Filing of 2290's Coming Soon!

This year, the IRS is mandating that all carriers with over 25 vehicles e-file their Form 2290 – the Heavy Highway Vehicle Use Tax.
