WHAT TO EXPECT DURING RENEWALS!

DMV Staggered Registrations are starting to run more smoothly. Plan on submitting your Renewal applications and fees 45 days prior to your expiration date so that your 2010 Cab Cards and stickers arrive on time. Remember, there is no grace period and if your tags are not current you can be ticketed. Call us for a FREE Estimate!

Grace Periods

IFTA *allows you to operate* with 2009 tags through February, 2010. But only if renewal applications are turned in and all fees paid in full. Oregon and New Mexico do not have any grace periods. Be sure your reporting is current so that your permits can be sent to you without delays.

Supplemental Billings

The DMV & Board of Equalization must be paid in full before tags, decals & Cab Cards are released. Watch your mail and call us if you receive a billing notice and don't understand what to do with it. But don't put it aside! That will cause delays in receiving your tags, cab cards, and decals to operate in 2010!
