Apr 5th – March Trip Logs received by today earn a \$5 discount on next months billing!

Apr 10th – All Trip Logs for January, February, & March due! The IFTA tax return for 1st Quarter is due April 30th.

Apr 15th – Income taxes are due!!

Apr 30th – IFTA Quarterly Reports due!!

May 31st – Kansas Annual Carrier Reports due.

BIENNIAL INSPECTIONS (BIT)!

Don't forget it is your job to request your next BIT inspection!

Late Filing penalties . . . will start being added to your fees for BIT inspections if you do not file an application for your next BIT inspection in a timely fashion. The rule is you must file an application for your *next* BIT inspection 17 months after your *last* BIT inspection. Applications submitted more than 30 days late are subject to a 60% penalty!!

Let us know when your last BIT inspection was and we will help you keep track of when your next application needs to be filed.
