**Feb 5<sup>th</sup>** – January Trip Logs received by today earn a \$5 discount on next months billing!

**February**– watch for your 2009 tags and decals to arrive in the mail if you have not already received them! (Clients who submitted their applications in November already have their permits!) We are following-up for clients whose permits have not arrived. Remember, if tax returns or fees are outstanding the agencies will not release your 2009 permits.

**February 16<sup>th</sup>** – President's Day!

**February 28<sup>th</sup>** – **Grace periods end!**

**Feb – March** – Watch for miscellaneous tax forms from Arkansas and Kansas to arrive in your mail. **DO NOT IGNORE THEM!** You must file them even if you did not travel in those states. If you would like our assistance just send the form to our office and we will help you! Penalties and interest are assessed if you do not respond.

**Mar 31<sup>st</sup>** – Arkansas Carrier Reports Due!

**Mar 31<sup>st</sup>** – New York HUT Permits Expire!
