## Important Dates

**Jan 5<sup>th</sup>** – December Trip Logs received by today earn a \$5 discount on next months billing!

**Jan 10<sup>th</sup>** – All trip logs for Oct, Nov & Dec are due so that your 4<sup>th</sup> Quarter IFTA reports can be filed by the filing deadline.

**January** – watch for your 2008 tags and decals to arrive in the mail. IFTA is *slow* this year. As of 1/2/08 the Board of Equalization is still working on renewal applications they received in September! Remember you have a grace period through 2/29/08 to operate with your 2007 decals.

**Jan – March** – Watch for miscellaneous tax forms from Arkansas and Kansas to arrive in your mail. DO NOT IGNORE THEM! If you would like our assistance just send the form to our office and we will help you! Penalties and interest are assessed if you do not respond.

**Jan 31<sup>st</sup>** – 4<sup>th</sup> Quarter IFTA reports due!
