Important Dates

March 25 – be sure your Income Tax Organizer is returned to our office so that your income tax return can be prepared and filed by 4/15/09.

March – Watch for miscellaneous tax forms from Arkansas and Kansas to arrive in your mail. DO NOT IGNORE THEM! You must file them even if you did not travel in those states. If you would like our assistance just send the form to our office and we will help you! Penalties and interest are assessed if you do not respond.

Mar 31st – Arkansas Carrier Reports Due!

Apr 5th – March Trip Logs received by today earn a \$5 discount on next months billing!

Apr 10th – All Trip Logs for January, February, & March due! The IFTA tax return for 1st Quarter is due April 20th.

Apr 15th – Income taxes are due!!

Apr 30th – IFTA Quarterly Reports due!!

When New York moves forward with Series #20 HUT permits, they will send renewal packages in the mail and grant a 90 day window to renew. Please call our office as soon as you start receiving your renewal packages and we will be able to help you more.

If you have any trouble on the road due to expired registration, please call our office and we will help you.*

Warning!! *The IFTA Grace Period has expired.*
